The organization was required to pursue a process of formal recognition through Fraternity and Sorority Life and/or Office of Student Affairs, received and must deliver mandatory training and educational sanctions regarding Hazing definitions and prevention.

The organization was restricted from recruiting or admitting any new students through the 2026-2027 academic year, placed on a social probation limited social and pre-professional events, as well as mandatory training and education sanction around hazing, event registration, and harm reduction, and requiring significant oversight from the Office of Student Affairs.

The organization was placed on an organizational probation status for a full year, mandatory training and educational sanction around Hazing, and have recruitment and new member orientation oversight by Office of Fraternity and Sorority Life.

Some members were in costume. These activities took place in the evening prior to a sanctioned mixer. A student leader was also found responsible due to individual actions taken.	Both organizations were placed on probation status with a full year of suspended social privileges, mandatory training and education (alcohol and hazing) and leadership development. For the individual student, sanctions were imposed.

Members received education and outreach from various campus partners, as well, that focused on hazing education and team building skills.

The team did not participate in scheduled practices or competitions as a result of the finding.
